### 19.30 – 20.00: Parallel sessions

a) dr. Tessa Lansu. Tessa is assistant professor at the BSI & Department of Psychology, Radboud University. She examines the role of implicit automatic processes in children's and adolescents' social perceptions of their peers, early adolescents' implicit evaluation of and attention for high-status and low-status peers that vary in popularity, and how implicit and explicit evaluation of a peer are related to behavior towards that peer. Moreover, Tessa studies aggression, bullying & victimization, and social cognitions related to these constructs.

b) Nella Geurts. Nella attended the Research Master Social and Cultural Science. Now she studies the integration paradox, which is the paradox where structurally integrated migrants appear not so well integrated in the socio-cultural domain. She studies this with a mixed-methods approach, using both surveys and in-depth interviews. In addition, she is an editor at Sociologie Magazine and Mens & Maatschappij.

### 20.15 – 20.45: Parallel sessions

a) Marco Schauer. Marco obtained his master's in Behavioural Science just last year. Since then he has worked as a User Experience Researcher for the social network XING (German version of LinkedIn) before starting a PhD in February at the Leuphana University of Lüneburg. In his PhD, Marco will investigate the role of uncertainty and moral values in business and political negotiations.

b) dr. Marieke van Kesteren. Marieke received her MSc in Cognitive Neuroscience at Radboud University, where she went on to get her PhD. She then went on to complete a post-doc position at Radboud UMC, followed by a two-year post-doc at Stanford University and a three-year post-doc at Vrije Universiteit Amsterdam. Now she works in grant consulting. She will primarily be presenting on her experience as a post-doctoral researcher.

### 20.45 – 21.15: Parallel sessions

a) dr. Marieke Westendorp. Postdoc researcher Mariske has done a bachelor and master in cultural anthropology and development studies and in comparative religious studies. She finished a PhD program at the department of anthropology at Macquari university, where she investigated the ways in which religion (Catholicism and Buddhism) features in an East Asian urban setting. Afterwards, she taught courses at different universities in the Netherlands and currently she studies cemeteries and crematoria as public spaces of belonging in Europe.

b) dr. Angela de Bruin. Angela completed her BA in Linguistics and MSc in Cognitive Neuroscience at the Radboud University. In 2013 she moved to Edinburgh, where she completed her PhD in Psychology. Between 2016 and 2019, she was working as a postdoctoral researcher and Marie Curie Fellow at the Basque Center on Cognition, Brain and Language (San Sebastián, Spain). She is now a lecturer at University of York. Her research interests include bilingualism, language switching, language production, executive control, and cognitive ageing.

### 19.30 – 20.00: Parallel sessions

a) dr. Marieke Kroezen. Marieke works as a senior researcher and project manager in the department of Elderly Care at the Trimbos-institute (the Netherlands Institute of Mental Health and Addiction). Her work mainly focuses on people with dementia and their caregivers, and gerontopsychiatry. She obtained her PhD on nurse prescribing and has worked in health services research ever since. Her areas of expertise include the health workforce (planning, recruitment and retention), skill-mix, people with intellectual disabilities and elderly care.

b) dr. Jet Bakels. Jet Bakels has studied Cultural Anthropology at the University of Amsterdam after which she did her PhD on 'The pact with the tiger'. She has worked as an (independent) researcher in the regions of Indonesia, Nepal, Canada, France, The Netherlands and Bonaire, on various expositions, and has written multiple (children's) books. Now, Jet is working as a researcher for the Dutch Centre For Intangible Cultural Heritage. Her goal has always been to generate knowledge about, respect for and involvement in nature and its wild animals.

### 20.15 – 20.45: Parallel sessions

a) Iris Hulzink. Her background is in Cognitive Neuroscience (Radboud University), specialised in Learning, Memory & Plasticity. After graduation, she started working at a medical technology startup (Neurocast), after which she made the switch to management consulting (at Boston Consulting Group), aimed specifically at projects with a technology angle.

b) Daniëlle Tump. Daniëlle graduated from the Cognitive Neuroscience. After being a research intern at the Brain Computer Interface lab and at the Cognitive Neuroscience for Sleep and Memory lab of the Donders Institute, she worked as a BCI Software Engineer and Research Lead before becoming a Product Manager at MindAffect, which developed a brain computer interface that allows ALS or locked-in patients to communicate by controlling a computer with brain signals. From June 2020 onwards, Daniëlle started as a Biomedical Researcher at the imec OnePlanet Research Center on wearables and mental wellbeing.

a) Malte Köster. Malte is an alumni from the Cognitive Neuroscience Research Master. After he graduated, he has worked as a researcher in the Cognitive Neuroscience Laboratory at the German Primate Center for a year before turning to industry. He started working as an IT consultant for the Ardour Consulting Group GmbH, and after almost 3 years he became a Business Intelligence Analyst for ABOUT YOU GmbH. Malte has now been working as an analytical consultant at Google for nearly 5 years. In this session he will share his experience working in a big company as someone with a research background.

b) Coco de Jongh. Coco attended the Research Master Social and Cultural Science. After her study she became a researcher at the municipality of Rotterdam, where she provided information about the physical and social domain. This information was used for policy making in Rotterdam, to improve the living environment of the inhabitants. Now she works for the municipality in Ede, for the social domain.
